Subject: Proposed Changes to the SVTHS Student Handbook

Superintendent McIntosh & SVTHS Curriculum Subcommittee,

I look forward to attending the Curriculum Subcommittee meeting on Tuesday, April 29, 2025 to present a number of important proposed changes to the SVTHS Student Handbook for the 2025-2026 school year. An overview of those changes is provided for your convenience in the table below. Some of those changes are simple (i.e. update dates, titles, extensions, etc.), while others are more substantive (i.e. attendance policy, GPA scale, etc.). Additional documents are provided for each of the more substantive changes so you can view the full language and identify the exact changes to the language. The proposals provided result from months (and in some cases years) of collaboration amongst SVTHS School Council members and with SVTHS Administrators and staff. I look forward to the opportunity to discuss these proposals with you and to provide additional context to them.

The list of proposed changes below was approved unanimously by the SVTHS School Council on Tuesday, April 10, 2025.

Notice of Non- Discrimination	Update using language from attorney to comply with new legal requirements.
Welcome	Update message, dates and extensions.
Table of Contents	Update to match changes throughout; update dates.
Part I. Introduction	Update language to reflect changes to how permissions will be collected electronically through Aspen and New Student Registration.
1-1: School Committee	Update list of School Committee members & titles.
1-2: School Calendar	Update with the 2025-2026 School Calendar.

2-2: Bus Transportation	Update website link for bus routes.
Part 3. School Attendance	Update to reflect multiple changes endorsed by the School Council, after two years of work on this section of the Student Handbook at School Council meetings. Proposed revisions were approved unanimously by the 2024-2025 SVTHS School Council. These changes address the excessive number of absences allowed under our current policy, and the excessive class absences due to early dismissals, as allowed per the current policy. 4-11: Cooperative Education Program and Procedures	Update language to clarify that both unexcused and excused absences count.
